(iii) Tuition and Tuition Related Fees

Richard Goyder moved, seconded by Karen Webb, "That the Board of Governors approve an increase in annual tuition fees for 2012-13 for domestic students consistent with the limits provided in the (pending) policy directives of the Ministry of Training, Colleges and Universities; and, that the Board of Governors approve an increase in the standard annual tuition fees for international students for 2012-13 of up to 4%, and up to 4% for 2013-14, for certificate, diploma, graduate certificate, degree and English Language Institute programs."

(iv) Compulsory Ancillary Fees

Richard Goyder moved, seconded by Donna Duncan, "That the Board of Governors approve the proposed Compulsory Ancillary Fee changes for 2012-13 and the proposed 3-year Academic IT Fee plan for 2012-13 to 2014-15, *subject to approval by the Ancillary Fees Protocol Committee.*"

(v) International Health Insurance Fee

Richard Goyder moved, seconded by Richard Lim, "That the Board of Governors approve the proposed \$40 annual increase to the International Health Insurance Fee, to a total of \$480 per student per year, effective 2012-13, to reflect insurance premium increases."
